**A RESOLUTION RESPECTFULLY URGING THE DEPARTMENT OF BUDGET AND MANAGEMENT OFFICE XI, THROUGH ITS REGIONAL DIRECTOR GARY R. MARTEL, FOR THE SPEEDY REVIEW OF THE APPROPRIATION ORDINANCE NO. 17-11-01-2024, THE FY 2024 GENERAL FUND ANNUAL BUDGET OF THE PROVINCE OF DAVAO ORIENTAL, TO RECTIFY SOME SITUATIONS THAT CAUSES DELAY IN DELIVERING SERVICES TO OUR CONSTITUENTS.**

**WHEREAS**, Section 326 of RA 7160 mandates the Department of Budget and Management to review ordinances authorizing the annual or supplemental appropriations of provinces, highly-urbanized cities, independent component cities, and municipalities within the Metropolitan Manila Area in accordance with the immediately succeeding section;

**WHEREAS**, the Sangguniang Panlalawigan of Davao Oriental enacted the Appropriation Ordinance No. 17-11-01-2024 authorizing the FY 2024 General Fund Annual Budget of the Province on January 10, 2024;

**WHEREAS**, however, on February 12, 2024, the Honorable Governor Niño Sotero L. Uy, Jr., vetoed the entire appropriation ordinance. Subsequently, on February 21, 2024, the Sangguniang Panlalawigan exercised its authority and successfully overrode the Governor's veto, pursuant to Section 55(c) of RA 7160;

**WHEREAS**, the Executive Department of the Provincial Government of Davao Oriental, through its Provincial Budget Office did not execute the said approved Appropriation Ordinance of the Sangguniang Panlalawigan for CY 2024. Thus, this hinders the operationalization of SP operations and causes delays in delivering services to the constituents of the province;

**WHEREAS**, in order to resolve the abovementioned situations, thus, this august body unanimously agreed to respectfully request and urge the Department of Budget and Management for its speedy review of Appropriation Ordinance No. 17-11-01-2024 which was submitted on February 29, 2024;

**WHEREFORE**, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Harold A. Montes, Anna Cheryl N. Castro, Eleuterio C. Manaytay, and Daud V. Linsag, it was

**RESOLVED**, as it is hereby resolved, **RESPECTFULLY URGING THE DEPARTMENT OF BUDGET AND MANAGEMENT OFFICE XI, THROUGH ITS REGIONAL DIRECTOR GARY R.
