A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), AND DEED OF DONATION AND ACCEPTANCE (DODA) WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF LUPON, REPRESENTED BY ITS MAYOR, HONORABLE ERLINDA D. LIM, RELATIVE TO THE ON-GOING IMPLEMENTATION OF THE PROVINCEWIDE INSTALLATION OF THE ENHANCED TAX REVENUE ASSESSMENT AND COLLECTION SYSTEM (ETRACS).

WHEREAS, the provincewide installation of the Enhanced Tax Revenue Assessment and Collection System (ETRACS) intends to automate the real property tax administration and local revenue collection, which is developed and maintained by RAMESES SYSTEMS INC., thus, the province will be able to adopt and implement a uniform

IS that will enable the system interoperability linkage between the PLGU and its component MLGUs, thereby significantly improving the treasury and assessment operations of this Province;

WHEREAS, the Provincial Government of Davao Oriental and the Municipal Government Unit of Lupon shall perform their responsibilities in accordance with the provisions of the MOA and undertake all means necessary to realize, promote, and sustain the implementation of ETRACS in this province;

WHEREAS, the Provincial Government, subject to the existing applicable laws, rules, and regulations, shall procure and turn over (donate) to MLGU of Lupon all hardware; equipment, computers, devices, cables, and other materials to be used in the installation and implementation of ETRACS in the respective Treasurer and Assessor's Office of the said municipality;

WHEREAS, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the provincial government, shall "represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Eleuterio C. Manaytay, Daud V. Linsag, Anna Cheryl N. Castro, and Harold A. Montes, it was

RESOLVED, as it is hereby resolved, AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA), AND DEED OF DONATION AND ACCEPTANCE (DODA) WITH THE MUNICIPAL LOCAL GOVERNMENT UNIT OF LUPON, REPRESENTED BY ITS MAYOR, HONORABLE ERLINDA D. LIM, RELATIVE TO THE ON-GOING IMPLEMENTATION OF THE PROVINCEWIDE INSTALLATION OF THE ENHANCED TAX REVENUE ASSESSMENT AND COLLECTION SYSTEM (ETRACS);
