A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 02, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.

WHEREAS, submitted for review before this august body is the Municipal Ordinance No. 02, series of 2024, of the Sangguniang Bayan of Governor Generoso, this Province, entitled: **“AN ORDINANCE AUTHORIZING HON. JUANITO C. INOJALES, MUNICIPAL MAYOR, THIS MUNICIPALITY TO ENTER, TRANSACT AND ASSIGN THE TWENTY PERCENT (20%) OF LGU-GOVERNOR GENEROSO NATIONAL TAX ALLOTMENT (NTA) TO LAND BANK OF THE PHILIPPINES (LBP) RELATIVE TO THE FINANCIAL BORROWINGS/LOAN OF THE SAID LGU WITH THE AFORESAID GOVERNMENT BANK”;**

WHEREAS, said Municipal Ordinance was enacted by the Sangguniang Bayan on February 6, 2024 and the same was approved by the Municipal Mayor on February 20, 2024;

WHEREAS, Section 296(a) and Article 394(a) of RA 7160 and its IRR, respectively, states that: *“the LGU may create indebtedness, and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program”*;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Shanine C. Lintogonan, Daud V. Linsag, and Jossone Michael G. Dayanghirang, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 02, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO;**




