A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 585, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING BY INSERTION/DELETION ON ARTICLE VII, SECTIONS 50, 57 AND 58 OF CITY ORDINANCE NO. 578, S. 2023 “AN ORDINANCE ADOPTING THE ECONOMIC ENTERPRISE CODE OF THE CITY OF MATI, DAVAO ORIENTAL”, SUBJECT TO THE PROVISIONS OF REPUBLIC ACT 7160 AND OTHER APPLICABLE LAWS RELATIVE THERETO.

WHEREAS, Section 16 of the Local Government Code of 1991 states that: *“Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied there from, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare”;*

WHEREAS, presented for review before the August Body is City Ordinance No. 585, series of 2024, forwarded by Mr. Juvy L. Mabini, Secretary to the Sangguniang Panlungsod of Mati, Davao Oriental, docketed as Communication No. 17-874-2024, item number 1;

WHEREAS, the said Ordinance was enacted by the 7th Sangguniang Panlungsod of the City of Mati, this province on the 9th day of January 2024, purposely to set guidelines for the Public Utility Van application of franchise to operate a terminal outside the Mati Centennial Transport Terminal Complex;

WHEREFORE, on motion of SP Member Daud V. Linsag, duly and jointly seconded by SP Members Harold A. Montes and Andy A. Monday, it was




