**A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-02, OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE IMPLEMENTING THE SUSTAINABLE CORN PRODUCTION IN SLOPING AREAS (SCoPSA) PROGRAM IN THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO SECTION 447(A)(1) OF REPUBLIC ACT NO. 7160 OR THE LOCAL GOVERNMENT CODE OF 1991.**

**WHEREAS**, SB Secretary Ms. Fatima L. Malaluan of Lupon, Davao Oriental, submitted Municipal Ordinance No. 2024-02, for legislative review and appropriate action of this august body;

**WHEREAS**, the Municipality of Lupon is one of the corn producing municipalities in Davao Oriental. Due to the rapid growing of population, portion of the upland landscape is being converted to areas that are permanently farmed;

**WHEREAS**, the SCoPSA program is implemented within the territorial jurisdiction of the Municipality, particularly on the corn producing areas that are vulnerable to soil erosion, to increase farm productivity, regulate upland farming, provide new agricultural technologies especially in hilly areas, develop corn production areas as agro-tourism, implement soil and water conservation measure to address environmental problems;


