A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NO. 02, SERIES OF 2024, ISSUED BY THE HONORABLE CITY MAYOR MICHELLE N. RABAT OF MATI, DAVAO ORIENTAL, RE: “TRANSFERRING THE SUPERVISION OF THE LOCAL YOUTH DEVELOPMENT OFFICE (LYDO) FROM THE CITY SOCIAL WELFARE AND DEVELOPMENT OFFICE (CSWDO) TO THE CITY PLANNING AND DEVELOPMENT OFFICE (CPDO)”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF REPUBLIC ACT 7160.

WHEREAS, Section 25 of Republic Act 10742 or also known as *Sangguniang Kabataan Reform Act of 2015* as amended by Republic Act No. 11768, provides that: “*There shall be in every province, city and municipality a Youth Development Office which shall be headed by a youth development officer with the rank of at least division chief. Such may be put under the Office of the Local Chief Executive, the Office of the Planning and Development, the Office of the Social Welfare, or any other office deemed appropriate by the Local Government Unit xxx*”;


