A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 320-17-2024 OF THE SANGGUNIANG BAYAN OF SAN ISIDRO, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.

WHEREAS, submitted for review before this august body is Municipal Ordinance No. 320-17-2024, entitled: **“AN ORDINANCE APPROVING AND RATIFYING THE TERMS AND CONDITIONS OF THE TERM LOAN AGREEMENTS AND DEED OF ASSIGNMENT OF DEPOSIT WITH HOLD OUT AND CONTROL AGREEMENT SIGNED AND ENTERED INTO BY BETWEEN MUNICIPALITY OF SAN ISIDRO REPRESENTED BY THE LOCAL CHIEF EXECUTIVE, HON. MARIA ANGELICA T. GO AND THE DEVELOPMENT BANK OF THE PHILIPPINES (DBP), REPRESENTED BY ITS LENDING CENTER HEAD, AVP AMELITA B. PINANDAY, WITH LOAN AMOUNT OF ONE HUNDRED FIFTEEN MILLION PESOS (P115,000,000.00) TO**

FINANCE THE FOLLOWING PROJECTS: A) ACQUISITION OF LOT SITE FOR GOVERNMENT CENTER – PHP25,000,000.00; AND B) PROCUREMENT OF BRAND-NEW LOCALLY SOURCED HEAVY EQUIPMENT AND RESCUE VEHICLES AND INSTALLATION OF SOLAR STREETLIGHTS – PHP 90,000,000.00”;

WHEREAS, the said Municipal Ordinance was enacted by the Sangguniang Bayan on March 8, 2024, the same was approved by the Municipal Mayor on March 11, 2024, and was transmitted for review on March 12, 2024;

WHEREAS, upon further review of the subject Municipal Ordinance, this Sangguniang Panlalawigan through its Committee on Finance, Budget and Appropriation finds that Section 3(viii) of the Ordinance is ambiguous since the projects to be funded under the said loan facility are already included in the LGU’s approved annual investment plan;

WHEREAS, all premises considered, the subject Ordinance is in accordance with Section 447(a)(2)(iii) and Rule XXXIII Article 395(d) of RA 7160 and its IRR, respectively;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Shanine C. Lintogonan, Daud V. Linsag, and Stephen Paul L. Uy, it was




