A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NOS. 09, 11, 19, 20, 21, AND 23, ALL SERIES OF 2024, ISSUED BY THE HONORABLE CITY MAYOR MICHELLE N. RABAT OF MATI, DAVAO ORIENTAL, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455 (B)(2)(iii) OF REPUBLIC ACT 7160.

WHEREAS, the city mayor, as chief executive of the city government has the power to issue such Executive Orders for the faithful and appropriate enforcement and execution of laws and ordinances, pursuant to the above cited provisions;

WHEREAS, submitted for review before the August Body are Executive Order Nos. 09, 11, 19, 20, 21, and 23, all series of 2024, which pertain to the declaration of the City Mayor Michelle N. Rabat on the suspension of classes in the preschool elementary, secondary, and tertiary levels of public and private schools, and work in all government offices in the City of Mati from January 16, 18, 19, 30, and 31; and February 1 and 2, 2024, as a precautionary measure in view of the continuous

moderate to heavy rains affecting the City of Mati and due to the effects of the trough of the Low Pressure Area (LPA);

WHEREAS, Section 2 of Presidential Executive Order No. 66, series of 2012, provides that: *“In the absence of typhoon signal warnings from PAGASA, localized cancellation or suspension of classes and work in government offices may be implemented by local chief executives, as chairmen of the Local Disaster Risk Reduction and Management Council (LDRRMC) concerned, in coordination with PAGASA and the NDRRMC, specifically in flood-prone or high risk areas”*;




