A RESOLUTION CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NOS. 14, 17, AND 18, ALL SERIES OF 2024, ISSUED BY THE HONORABLE CITY MAYOR MICHELLE N. RABAT OF MATI, DAVAO ORIENTAL, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF REPUBLIC ACT 7160.

WHEREAS, EO No. 14, series of 2024, Re: “Amending Executive Order Nos. 09, series of 2019, 70, series of 2020, 58, series of 2021, and 54, series of 2022, Re: Reconstituting the Urban Development and Housing Board (UDHB), by updating its membership”, was issued on January 25, 2024;

WHEREAS, Executive Order Nos. 17 and 18, series of 2024, were issued on January 25, 2024 to amend previously issued executive orders relative to the creation of Local Inter-Agency Committee (LIAC) by updating its membership to facilitate various Housing Projects in the City of Mati and shall coordinate the thrusts, objectives, activities, and policy and decision making of all agencies and organizations concerned for the implementation of programs, projects, plans and activities relative to respective relocation and resettlement;

WHEREAS, Section 39 of Republic Act No. 7292, otherwise known as "*Urban Development and Housing Act of 1992*", recognizes the role of Local Government Units (LGUs) being charged with the implementation of Urban Development and Housing on their respective localities in coordination with the Housing and Development Coordinating Council, the national housing agencies, the Presidential Commission for the Urban Poor, the private sector and other non-government organizations;

WHEREAS, Section 468(a)(1)(i) of RA. 7160, provides among others, the power of the Sangguniang Panlalawigan to "*review all ordinances approved by the sanggunians of component cities and municipalities and executive orders issued by the mayor of component city to determine whether these are within the scope of the prescribed powers of the sanggunian and of the mayor*";

WHEREFORE, on motion of SP Member Eleuterio C. Manaytay, duly and jointly seconded by SP Members Andy A. Monday, Shanine C. Lintogonan, Anna Cheryl N. Castro, Michelle M. Centeno, Marietta D. Palmera, and Shella Marie S. Go, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE VALIDITY OF EXECUTIVE ORDER NOS. 14, 17, AND 18, ALL SERIES OF 2024, ISSUED BY THE HONORABLE CITY MAYOR MICHELLE N. 
