A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 09, SERIES OF 2023, OF THE MUNICIPALITY OF BAGANGA, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 09, series of 2023, of the Municipality of Baganga, Davao Oriental, authorizing its FY 2023 General Fund Supplemental Budget No. 02, involving an appropriation of <u>FOUR MILLION NINE HUNDRED SEVENTY THOUSAND TWO HUNDRED FORTY-EIGHT PESOS & 38/100 (₱4,970,248.38)</u>, was submitted to this Sanggunian for review on February 13, 2024, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 09, Series of 2023 of the Municipality of Baganga, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160;

MOREOVER, the LGU is reminded to indicate the Date of Approval of the Appropriation Ordinance by the Local Chief Executive, the same being vital in determining the date of which is required that within three (3) days after approval of the ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review, pursuant to Section 56 in relation with Sections 326 and 327 of the Local Government Code, and the provisions under the Budget Operation Manual for Local Government Units issued under the Local Budget Circular No. 152, dated August 2, 2023.

**RESOLVED FURTHER**, to inform the Municipality of Baganga, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Baganga, Davao Oriental, through the Municipal Mayor.
