A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE TECHNICAL EDUCATION AND SKILLS DEVELOPMENT AUTHORITY (TESDA) REGION XI, REPRESENTED BY ITS REGIONAL DIRECTOR, MS. ASHARY A. BANTO, RELATIVE TO THE PROVISION OF TECHNICAL EDUCATION AND SKILLS DEVELOPMENT PROGRAMS AND COMPLIMENTARY SUPPORT SERVICES FOR SOCIO-ECONOMIC UPLIFTMENT OF BENEFICIARIES IN THE PROVINCE OF DAVAO ORIENTAL.

WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the Provincial Government, shall "represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREAS, the Honorable Governor Niño Sotero L. Uy, Jr., sought authority from the August Body to enter into an agreement with TESDA Region XI, as stipulated in his letter dated April 2, 2024, docketed as Communication No. 17-900-2024;

WHEREAS, the Sangguniang Panlalawigan of this province, adheres to "promote and strengthen the quality of technical education and skills development programs to attain international competitiveness", pursuant to Section 3(a) of Republic Act 7796, otherwise known as "Technical Education and Skills Development Act of 1994" or the "TESDA Act of 1994";
