A RESOLUTION RETURNING TO THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THE HEREIN LETTER DOCKETED AS COMMUNICATION NO. 17-889-2024, FOR WHATEVER ACTION DEEMED APPROPRIATE THEREON.

WHEREAS, COMMUNICATION NO. 17-889-2024 pertains to the letter from the Honorable Governor Niño Sotero L. Uy, Jr., requesting this August Body to pass a Resolution to grant the exemption from the Moratorium pursuant to the provisions under Section 5 of Executive Order No. 15, series of 2023, dated April 11, 2023, for the lot donation to the Department of the Interior and Local Government - Davao Oriental Provincial Office and Land Transportation Office;

WHEREAS, enclosed therewith are Resolution Nos. 09 and 10, both series of 2024, of the Development Management and Coordinating Committee (DMCC) on the Provincial Government Property in Barangay Dahican, City of Mati, recommending to

grant the request of DILG and LTO for the exemption from the said Moratorium, respectively. Said resolutions were duly approved by the Honorable Governor;

**WHEREAS**, following the discussion with the representatives from DMCC, it was discovered that the Communication in question, together with the attached copies of DMCC Resolutions, was furnished to this August Body for information only, and was not intended for the Sanggunian to grant the said exemption;

WHEREAS, furthermore, in accordance with the Process Flow for Land Grant under the in-progress Provincial Government Integrated Action Plan, considering that the donation of lots in favor to DILG Provincial Office and Land Transportation Office has been approved/granted exemption from the Moratorium, the foregoing offices can now facilitate the processing of the titling of the said lot and transfer of ownership;

WHEREAS, accordingly, in order to fully proceed with the processing of titling and Transfer of ownership in favor to the foregoing requesting offices, the Honorable Governor shall be authorized by the Sangguniang Panlalawigan to represent the Provincial Government in the subdivision plan survey for government offices;

WHEREAS, all premises considered, this Sangguniang Panlalawigan acknowledges the information provided through the subject Communication. Nonetheless, before this August Body takes appropriate legislative action, there is a need for an appropriate request from the Local Chief Executive that will serve as guidance and reference for such legislative action;

**WHEREFORE,** on motion of SP Member Eleuterio C. Manaytay, duly and jointly seconded by SP Members Shanine C. Lintogonan, Andy A. Monday, Rotchie M. Ravelo, and Harold A. Montes, it was
