A RESOLUTION CONFIRMING THE APPROVAL OF MUNICIPAL ORDINANCE NO. 2024-04, AND CITY ORDINANCE NO. 599, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF BANAYBANAY AND SANGGUNIANG PANLUNGSOD OF MATI, RESPECTIVELY, BOTH OF THIS PROVINCE, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF BOTH SANGGUNIANs, PURSUANT TO ARTICLE III, SECTIONS 447(a)(1) AND 458(a)(1) OF THE REPUBLIC ACT 7160, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, Municipal Ordinance No. 2024-04 of the Sangguniang Bayan of Banaybanay, Davao Oriental, entitled: “AN ORDINANCE MANDATING BUSINESSES OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE MUNICIPALITY OF BANAYBANAY, DAVAO ORIENTAL TO SECURE A PHILIPPINE NATIONAL POLICE (PNP) CERTIFICATE OF DISTRIBUTORSHIP BEFORE MANUFACTURING,

SELLING, USING OR DISTRIBUTING PNP UNIFORMS, INSIGNIAS, AND OTHER ACCOUTREMENTS AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF”;

WHEREAS, City Ordinance No. 599, series of 2024, of the Sangguniang Panlungsod of Mati, Davao Oriental, entitled: “AN ORDINANCE MANDATING BUSINESSES OPERATING WITHIN THE TERRITORIAL JURISDICTION OF THE CITY OF MATI, DAVAO ORIENTAL TO SECURE A PHILIPPINE NATIONAL POLICE (PNP) CERTIFICATE OF CONFORMITY AND/OR CERTIFICATE OF DISTRIBUTORSHIP BEFORE MANUFACTURING, SELLING, USING, OR DISTRIBUTING PNP UNIFORMS, INSIGNIAS, AND OTHER ACCOUTREMENTS AND PRESCRIBING PENALTIES FOR VIOLATIONS THEREOF”;

WHEREAS, the said ordinances shall be applied to all manufacturers/business establishments, distributors and persons or group engaged in business and any activities in their respective localities which are engaging in using the PNP uniforms, insignias and accoutrements;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Shanine C. Lintogonan and Anna Cheryl N. Castro, it was

RESOLVED, as it is hereby resolved, **CONFIRMING THE APPROVAL OF MUNICIPAL ORDINANCE NO. 2024-04, AND CITY ORDINANCE NO. 599, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF BANAYBANAY AND SANGGUNIANG PANLUNGSOD OF MATI, RESPECTIVELY, BOTH OF THIS PROVINCE, CONSIDERING THAT THE SAME ARE WITHIN THE PRESCRIBED POWERS OF BOTH SANGGUNIAN, PURSUANT TO ARTICLE III, SECTIONS 447(a)(1) AND 458(a)(1) OF THE REPUBLIC ACT 7160, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO;**




