WHEREAS, Municipal Ordinance No. 2024-04, entitled: "AN ORDINANCE CREATING THE SEXUALLY TRANSMITTED INFECTIONS (STI). IMMUNODEFICIENCY VIRUS (HIV) AND ACQUIRED IMMUNE DEFICIENCY SYNDROME (AIDS) COUNCIL IN THE MUNICIPALITY OF LUPON FOR THE PREVENTION AND CONTROL OF STI, HIV AND AIDS AND PROVIDING PENALTIES FOR VIOLATIONS THEREOF AND FOR OTHER PURPOSES":

WHEREAS, Municipal Ordinance No. 2024-05, entitled: "AN ORDINANCE PROVIDING SUPPORT TO THE ESTABLISHMENT OF ADOLESCENT-FRIENDLY HEALTH FACILITIES IN SCHOOLS/COMMUNITIES, AND CREATION OF A MUNICIPAL ADOLESCENT-FRIENDLY HEALTH FACILITY CERTIFICATION CORE TEAM IN THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL;

WHEREAS, in her letter dated May 2, 2024, Ms. Fatima L. Malaluan, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted Municipal Ordinance Nos. 2024-04 and 2024-05 for legislative review of the Sangguniang Panlalawigan;
