A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-08-03-2024 OF THE MUNICIPALITY OF CATEEL, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY.

WHEREAS, Appropriation Ordinance No. 01-08-03-2024 of the Municipality of Cateel, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 01 involving an appropriation of **TWENTY-SEVEN MILLION SEVEN HUNDRED** SEVENTY-NINE THOUSAND FOUR HUNDRED THIRTY-NINE PESOS & 89/100 (P27,779,439.89), was submitted to this Sanggunian for review on March 15, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Anna Cheryl N. Castro and Shanine C. Lintogonan, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 01-08-03-2024 of the Municipality of Cateel, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- Lump sum appropriations in Special Purpose Appropriations/Other MOOE/Capital Outlay, etc. shall be subject to Sections 305(b) and 335 of RA 9184 (Government Procurement Reform Act) and its Revised IRR, and other existing pertinent laws, rules and regulations imposing restraints on government expenditures.
- 2. The LGU shall record their financial transactions in accordance with the Revised Chart of Accounts for LGUs effective January 1, 2015, pursuant to COA Circular No. 2015-009, dated December 1, 2015.
- 3. The fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP) pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016.

RESOLVED FURTHER, to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.
