**A RESOLUTION INFORMING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THROUGH THE PROVINCIAL DEVELOPMENT COUNCIL (PDC), THAT THE HEREIN REQUEST FOR APPROVAL BY THE SANGGUNIANG PANLALAWIGAN IS PENDING THE SUBMISSION OF THE REVISED CY 2024 ANNUAL INVESTMENT PROGRAM (AIP) INCORPORATING/APPROVING THERETO THE NEW PPAs FUNDED UNDER THE REVISED CY 2024 LDRRMP, PURSUANT TO NDRRMC-DBM-DILG JMC NO. 2013-1.**

**WHEREAS,** submitted before this August Body is the letter from Honorable Governor Niño Sotero L. Uy, Jr., requesting for an appropriate legislative action for the PDRRMC Resolution No. 2, series of 2024;

**WHEREAS**, PDRRMC Resolution No. 2, series of 2024, entitled: "A RESOLUTION APPROVING THE REVISED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT FUND INVESTMENT PLAN (LDRRMFIP) CY 2024 AND AUTHORIZING THE UTILIZATION OF THE PORTION OF THE UNEXPENDED LDRRMF ACCRUED UNDER THE TRUST FUND AMOUNTING TO FIFTY-ONE MILLION FIVE HUNDRED FORTY-TWO THOUSAND TWO HUNDRED FOURTEEN PESOS AND TWENTY-SIX CENTAVOS (PHP 51,542,214.26) TO SUPPORT THE DISASTER RISK REDUCTION AND MANAGEMENT ACTIVITIES OF THE PROVINCE, AND ENDORSING THE SAME TO THE PROVINCIAL DEVELOPMENT COUNCIL AND THE SANGGUNIANG PANLALAWIGAN FOR THEIR APPROVAL AND APPROPRIATE LEGISLATIVE ACTION", was approved by the PDRRM Council on March 25, 2024;

**WHEREAS**, having been declared under the State of Calamity due to the effects of the Shear Line and the Trough of LPA, the Province of Davao Oriental has already obligated and utilized a total of Php 69,136,749.69 or 54% of the FY 2024 LDRRM Fund, including the 30% QRF;

**WHEREAS**, there are essential programs, projects, and activities that are being requested by various concerned agencies to be funded in the total amount of P51,542,214.26, particularly under the following sectors, to promote early recovery for the communities affected by the effects of the Shear Line and the Trough of LPA:

- A) Infrastructure Sector (PEO) = P 26,031,426.25 and P 4,579,688.01
- B) Agriculture, Fishery and Livestock Sector (PAGRO, PVET) = P 8,000,000.00
- C) Health sector (PHO) = P 2,931,100.00
- D) Social sector (PSWDO, PDRRMO) = P 10,000,000.00


**WHEREAS**, based on ENSO Alert System Status, threats and effects of El Niño will likely persist until March-April-May 2024 season, while the increasing possibility of La Niña is at 62% and will likely to develop in June-July-August season;

**WHEREAS**, in view of the abovementioned statistics, there is still a need for mitigation measures in connection with the effects of the Shear Line and the Trough of LPA and preparedness measures for the possible effects of abovementioned climate change;

**WHEREAS**, as provided under Item 6.5 of NDRRMC-DBM-DILG Joint Memorandum Circular No. 2013-1, dated March 25, 2013, the unexpended balances of the LDRRMF may be released and utilized for new expenditure items upon submission of a revised AIP as approved by the local Sanggunian and Local Chief Executive (LCE) upon the recommendation of the LDRRMC, in accordance with the approved LDRRMFIP;

**WHEREAS**, in view of the provisions of the said Joint Memorandum Circular, this Sangguniang Panlalawigan deems it necessary to ensure that the new PPAs to be funded under the CY 2024 LDRRM Fund are incorporated in the Revised AIP to be approved by this Sanggunian and the Local Chief Executive;

**WHEREAS**, the Municipality's Supplemental LDRRMFIP for CY 2024 was duly adopted by the Municipal Development Council, and the same was incorporated in their Revised Annual Investment Program;


