A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 601, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG PANLUNGSOD, SUBJECT TO SECTION 123 OF RA 7653, AS IMPLEMENTED BY THE BANGKO SENTRAL NG PILIPINAS CIRCULAR NO. 402, AND OTHER LAWS AND REGULATIONS PERTINENT THERETO.

WHEREAS, submitted for review before this august body is the City Ordinance No. 601, series of 2024, entitled: *“AN ORDINANCE AUTHORIZING THE PROPOSED BORROWING OF THE CITY GOVERNMENT OF MATI, PROVINCE OF DAVAO ORIENTAL REPRESENTED BY THE LOCAL CHIEF EXECUTIVE, HON. MICHELLE MARIE DENISE N. RABAT TO THE LANDBANK OF THE PHILIPPINES (LBP) – DAVAO DEL NORTE LENDING CENTER IN THE AMOUNT OF THREE HUNDRED SIXTY SIX MILLION AND FIVE HUNDRED THOUSAND PESOS (P366,500,000.00) TO FUND THE FOLLOWING PROJECTS: CONSTRUCTION PROJECTS –*

P158,000,000.00, POTABLE WATER SYSTEM – P20,000,000.00, INSTALLATION OF LED WALL – P7,000,000.00, WASTE WATER TREATMENT FACILITY – P17,000,000.00, SOLAR PANELS ROOFTOP – P76,500,000.00, HEAVY EQUIPMENT ACQUISITION – P86,000,000.00 AND SURVEY EQUIPMENT ACQUISITION – P2,000,000.00”;

WHEREAS, said City Ordinance was enacted by the Sangguniang Panlungsod on April 23, 2024;

WHEREAS, Section 296(a) and Article 394(a) of RA 7160 and its IRR, respectively, states that the LGU may create indebtedness and avail of credit facilities to finance local infrastructure and other socio-economic development projects in accordance with the approved local development plan and public investment program;

WHEREAS, pursuant to Section 56 of RA 7160, the LGU is herein reminded to indicate the Date of Approval of the ordinance by the Local Chief Executive, the same being vital in determining the date of which is required that within three (3) days after approval of the ordinance, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review;

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Stephen Paul L. Uy, Daud V. Linsag, Anna Cheryl N. Castro, and Harold A. Montes, it was
