UY, JR., RELATIVE TO HIS REQUEST FOR AN AUTHORITY FROM THE SANGGUNIANG PANLALAWIGAN TO ENTER INTO A JOINT VENTURE AGREEMENT (JVA) UNDER THE **PUBLIC-PRIVATE** PARTNERSHIP (PPP) WITH THE PREMIER 101 HEALTHCARE MANAGEMENT INC., FOR THE ESTABLISHMENT OF DAVAO ORIENTAL MULTISPECIALTY AND HEMODIALYSIS CENTER PROJECT WITH THE INFORMATION TO TAKE CONSIDERATIONS THE COMMENTS FROM ATTY. ELSA CAYETANO MATILAC, TECHNICAL ASSISTANT OF THE PROVINCIAL LEGAL OFFICE; AND ENGR. FREDDIE C. BENDULO, PROVINCIAL PLANNING AND DEVELOPMENT OFFICER.

WHEREAS, under Section 302 of Republic Act No. 7160, otherwise known as the Local Government Code of 1991, and likewise under Section 3 of Republic Act No. 7718, otherwise known as the Revised Philippine Build-Operate-and-Transfer (BOT)

Law, Local Government Units (LGUs) are authorized to enter into contract with any prequalified project proponent for financing, construction, operation and maintenance of financially viable agriculture and fisheries, infrastructure health, power or development facilities through any of the contract;

WHEREAS, Provincial Ordinance No. 14-03-04-2014, otherwise known as the Davao Oriental Public-Private Partnership (PPP) Ordinance aimed to encourage the pooling of resources and expertise between government and private sector entities through PPP as a viable, efficient and practical alternative in pursuing the development goals of the Provincial Government of Davao Oriental;

WHEREAS, guided by the said Provincial Ordinance, it also aimed to ensure all PPP Contracts are awarded through an open transparent and competitive process;

WHEREAS, it is the recommendation of the Sangguniang Panlalawigan to correct, finalize and update the said proposal of the Private Sector Proponent (PSP) and the Province based on the comments from Atty. Elsa Cayetano Matilac and Engr. Freddie C. Bendulo, which were attached to the said request of the Honorable Governor together with the draft Joint Venture Agreement;
