UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE LOCAL GOVERNMENT UNIT OF BAGANGA, THIS PROVINCE, REPRESENTED BY ITS MUNICIPAL MAYOR, HONORABLE RONALD V. LARA, RELATIVE TO THE UTILIZATION OF BALAY SILANGAN REFORMATION CENTER INTENDED FOR DRUG DEPENDENT PATIENTS, CONSIDERING THAT THE SAME IS IN ACCORDANCE WITH THE LAW.

WHEREAS, presented for consideration before the August Body is the letter-request from the Honorable Governor Niño Sotero L. Uy, Jr., dated June 25, 2024, requesting for the passage of a resolution authorizing him for the aforementioned subject matter, docketed as Communication No. 17-988-2024;

WHEREAS, Chapter III, Section 465 (b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the chief executive of the Provincial Government, shall “*represent the province in all its business transactions and sign in its behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance*”;




