A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 05, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF GOVERNOR GENEROSO, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE AMENDING MUNICIPAL NO. 3, SERIES OF 2014 ESTABLISHING A LOCAL COLLEGE INSTITUTION IN THE MUNICIPALITY OF GOVERNOR GENEROSO, PROVINCE OF DAVAO ORIENTAL TO BE KNOWN AS "GOVERNOR GENEROSO COLLEGE OF ARTS, SCIENCES AND TECHNOLOGY (GGCAST)", SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREAS, submitted for appropriate action before the August Body is the aforementioned Municipal Ordinance of the Sangguniang Bayan of Governor Generoso, this Province, docketed as Communication No. 17-983-2024;

WHEREAS, Chapter II, Section 16, of the Local Government Code of 1991, provides that: "Every Local Government Unit (LGU) shall exercise the powers expressly granted, those necessarily implied therefrom, as well as powers necessary, appropriate, or incidental for its efficient and effective governance, and those which are essential to the promotion of the general welfare xxx;

WHEREAS, Article XIV, Section 1, of the 1987 Philippine Constitution, provides that: "The State shall protect and promote the right of all citizens to quality education at all levels, and shall take appropriate steps to make such education accessible to all";
