A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-08 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2017-06, ENTITLED: “AN ORDINANCE ESTABLISHING THE LUPON FISH LANDING AND AUCTION CENTER THEREBY DECLARING THE SAME AS THE CONVERGENCE AND TRADING POST FOR SEAFOOD TRADERS AND FISHERMEN TO BOLSTER ECONOMIC GROWTH FOR THE FISHING INDUSTRY OF LUPON, DAVAO ORIENTAL”, SUBJECT TO EXISTING LAWS, RULES AND REGULATIONS RELATIVE THERETO.

WHEREFORE, on motion of SP Member Marietta D. Palmera, duly and jointly seconded by SP Members Michelle M. Centeno, Anna Cheryl N. Castro, and Rotchie M. Ravelo, it was




