**WHEREAS**, submitted for review before this August Body is the SB Resolution No. 36-06-06-2024 passed and approved by the Sangguniang Bayan of Cateel on June 6, 2024. The same was also approved by the Municipal Mayor on the same date;

**WHEREAS**, the Municipal Development Council had approved the said Comprehensive Development Plan through its MDC Resolution No. 01-2024, dated June 5, 2024;

**WHEREAS**, Section 106(a) of the RA 7160, states that: “Each local government unit shall have a comprehensive multi-sectoral development plan to be initiated by its development council and approved by its sanggunian xxx”;

**WHEREAS**, pursuant to Section 56 of R.A. 7160 which states that the Sangguniang Panlalawigan shall review the approved resolutions approving the local development plans, among other things, the said subject Comprehensive Development Plan of the Municipality of Cateel is found to be in order and in accordance with law;

**WHEREAS**, pursuant to Section 56(a) of RA 7160, the LGU is herein reminded to indicate the Date of Approval of the ordinances and resolutions by the Local Chief Executive, the same being vital in determining the date of which is required that within three (3) days after approval of the ordinance, the Secretary to the Sanggunian shall forward the said Ordinance to the Sangguniang Panlalawigan for review;


