

A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-09 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL. ENTITLED "AN ORDINANCE DECLARING EVERY 25TH DAY OF JUNE AS ARBOR DAY, ENJOINING ITS CELEBRATION AS AN ANNUAL EVENT OF TREE PLANTING, APPROPRIATING FUNDS THEREFOR AND FOR OTHER PURPOSES". CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF RA 7160.

WHEREAS, in her letter, dated June 25, 2024, Ms. Fatima L. Malaluan, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted Municipal Ordinance No. 2024-09, for a legislative review of the Sangguniang Panlalawigan;

WHEREAS, the Municipality of Lupon declares every 25th day of June as Arbor Day with the faithful intention to address the loss of natural resources through tree planting activity and to provide effective measures for its maintenance and sustainability;

WHEREAS, the said Municipal Ordinance was enacted by the Sangguniang Bayan of Lupon on its 20th Regular Session held on June 18, 2024 and the same was approved by Mayor Erlinda D. Lim on June 24, 2024;

WHEREFORE, on motion of SP Member Eleuterio C. Manaytay, duly and jointly seconded by SP Members Harold A. Montes, Andy A. Monday, Anna Cheryl N. Castro, Joselito B. Villademosa, and Rotchie M. Ravelo, it was
