**WHEREAS**, in her letter, dated June 25, 2024, Ms. Fatima L. Malaluan, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted Municipal Ordinance No. 2024-09, for a legislative review of the Sangguniang Panlalawigan;

**WHEREAS**, the Municipality of Lupon declares every 25<sup>th</sup> day of June as Arbor Day with the faithful intention to address the loss of natural resources through tree planting activity and to provide effective measures for its maintenance and sustainability;




