A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 15-01-04-2024 OF THE SANGGUNIANG BAYAN OF BOSTON, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE LOCALIZING REPUBLIC ACT NO. 11313 AND PROVIDING FOR THE GENDER-BASED PROTECTIVE MEASURES AGAINST SEXUAL HARASSMENT IN STREETS, PUBLIC SPACES, ONLINE WORKPLACES, AND EDUCATIONAL OR TRAINING INSTITUTIONS, AND PRESCRIBING PENALTIES FOR VIOLATION THEREOF", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF THE REPUBLIC ACT 7160.

WHEREAS, in her letter, dated June 25, 2024, Ms. Mary Gold B. Castres-Petor, Secretary to the Sangguniang Bayan of Boston, Davao Oriental, submitted the above Municipal Ordinance for legislative review of the Sangguniang Panlalawigan, docketed as Communication No. 17-986-2024:

WHEREAS, the said Municipal Ordinance was adopted and enacted to properly implement the mandate of RA 11313 within the municipality, in order to provide safe spaces to concerned sectors against any and all forms of sexual harassment and discrimination.
