A RESOLUTION CONFIRMING THE APPROVAL ON THE PASSAGE OF THE MUNICIPAL ORDINANCE NO. 2024-03 OF THE SANGGUNIANG BAYAN OF LUPON, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE AMENDING MUNICIPAL ORDINANCE NO. 2021-23, OTHERWISE KNOWN AS THE “REVISED LOCAL DISASTER RISK REDUCTION AND MANAGEMENT OFFICE (LDRRMO) ORDINANCE OF LUPON, DAVAO ORIENTAL, SPECIFICALLY ON SECTIONS 5, 6, & 7 THEREOF”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN PURSUANT TO ARTICLE III, SECTION 447(a)(1) OF REPUBLIC ACT 7160.

WHEREAS, in her letter, dated May 2, 2024, Miss Fatima L. Malaluan, MPA, Secretary to the Sangguniang Bayan of Lupon, Davao Oriental, submitted Municipal Ordinance No. 2024-03, for legislative review of the Sangguniang Panlalawigan;

WHEREAS, the said ordinance was enacted purposely for the creation of Municipal Government Department Head I (Local Disaster Risk Reduction and Management Officer), specifying its functions and responsibilities including LDRRMO's organizational structure;

WHEREAS, the same ordinance was enacted by the 20th Sangguniang Bayan of Lupon on its 91st Regular Session on April 22, 2024 and was approved by the Honorable Mayor Erlinda D. Lim on April 30, 2024;

WHEREFORE, on motion of SP Member Joselito B. Villademoso, duly and jointly seconded by SP Members Andy A. Monday, Harold A. Montes, and Eleuterio C. Manaytay, it was


