WHEREAS, in his letter, dated April 29, 2024, Mr. Eden Celestino S. Cacho, Secretary to the Sangguniang Bayan of Banaybanay, Davao Oriental, submitted Municipal Ordinance No. 2024-03, for legislative review of the Sangguniang Panlalawigan;
