**A RESOLUTION RETURNING TO THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., THE REQUEST FOR THE APPROVAL AND ADOPTION OF THE CY 2025 ANNUAL INVESTMENT PROGRAM OF THE PROVINCE OF DAVAO ORIENTAL, TOGETHER WITH THE RECOMMENDATIONS STATED HEREOF, FOR THE CONSIDERATION OF THE PROVINCIAL DEVELOPMENT COUNCIL.**

**WHEREAS**, submitted for confirmation before the August Body is PDC Resolution No. 6, series of 2024, which was approved by the Provincial Development Council on May 21, 2024;

**WHEREAS**, the same confirms the PDC-EXCOM Resolution No. 2, series of 2024, dated May 16, 2024, approving the proposed priority Programs/Projects/Activities for the CY 2025 Annual Investment Program (AIP) of Davao Oriental by Sector, namely: *Economic Development, Infrastructure Development, Social Development,*



*Environmental Management, Peace And Order, Public Safety And Security, Macro-Economy And Finance, And Institutional Development/Development Administration;*

**WHEREAS**, the foregoing adheres to the Local Budget Circular 152, which the said Sectoral Committees have determined the respective priority list of PPAs for CY 2025 which will be included in the Annual Investment Program, and in pursuant to Section 109 of RA 7160;

**WHEREAS**, Section 114(a) of the same Code provides that the PPAs proposed by Local Development Council shall be submitted to the sanggunian concerned for appropriate action. It is understood that such actions of the sanggunian does not include the power to modify, revise or alter the local development plans.

**WHEREAS**, accordingly, the August Body considers it appropriate to recommend some modifications and the inclusion of new PPAs under the Legislative Program for consideration by the Provincial Development Council and its Executive Committee, the same being necessary in support of legislative functions, process, and other related support services.

**WHEREAS**, it is recommended to modify/amend by increasing the amount of the following:

1. Under the General Administration and Support Services – **Office of the Provincial Vice Governor (1000-1-01-002-002-001)**
  - a. MOOE - from P26,100,000.00 to P36,225,000.00
  - b. CO - from P 5,000,000.00 to P10,000,000.00
2. Under the General Administration and Support Services – **Office of the Sangguniang Panlalawigan Members - Legislation (1000-1-01-002-002-002)**
  - a. MOOE - from P34,100,000.00 to P69,100,000.00
  - b. CO - from P 5,000,000.00 to P10,000,000.00

**WHEREAS**, it is recommended to include the following new proposed PPAs:

1. Funding for various proposed Coterminous positions - **Office of the Provincial Vice Governor**

	→	One (1) Executive Assistant II (SG-17)
	→	Two (2) Private Secretary I (SG-11)
2. Procurement of IT Equipments with Complete Accessories – **Office of the Secretary to the Sangguniang Panlalawigan**




