**A RESOLUTION DECLARING THE APPROPRIATION ORDINANCE NO. 01-2024 OF THE MUNICIPALITY OF LUPON, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.**

**WHEREAS**, Appropriation Ordinance No. 01-2024, of the Municipality of Lupon, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 01, involving an appropriation of **FIFTEEN MILLION ONE HUNDRED SEVEN THOUSAND TWO HUNDRED NINETY-FOUR PESOS (P15,107,294.00)**, was submitted to this Sanggunian for review on May 8, 2024, pursuant to the provisions of Republic Act No. 7160;

**WHEREAS**, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

**WHEREFORE**, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Andy A. Monday, and Harold A. Montes, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

**RESOLVED**, to declare Appropriation Ordinance No. 01-2024 of the Municipality of Lupon, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

1. The LGU is reminded that the positions in the official plantilla for career positions which are occupied by incumbents holding the permanent appointments shall be covered with adequate appropriations, as provided under Section 325(e) of the LGC;
2. Fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental AIP/Development Plan, pursuant to Sections 287 and 305(i) of the LGC; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016;
3. Implementation of PPAs under the 20% Development Fund shall be in accordance with DBM-DOF-DILG Joint Memorandum Circular No. 01, s. 2020;

**RESOLVED FURTHER**, to inform the Municipality of Lupon, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law;

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Lupon, Davao Oriental, through the Municipal Mayor.
