WHEREAS, submitted for review before the August Body is the abovementioned City Ordinance, docketed as Communication No. 17-1004-2024, Item No. 2. The same was referred to the Committee on Labor, Employment, Civil Service and Human Resource Development on July 17, 2024, for appropriate action;

WHEREAS, the corresponding parenthetical title of the retitled position Sanitation Inspector I to Administrative Aide VI under the office of the City Health Officer is not specified;

WHEREAS, parenthetical position title refers to the position title based on the actual duties and responsibilities in the Position Description Form and shall be the basis for the qualification standards (ORAOHRA, 2017). *Illustrative example: Administrative Aide III (Laborer II);*

WHEREAS, Section 76 of the Republic Act 7160, otherwise known as the Local Government Code of 1991, states that: "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";
