A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 2024-05 OF THE SANGGUNIANG BAYAN OF BANAYBANAY, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE IMPOSING A UNIFORM BARANGAY CLEARANCE FEE IN ANY BUSINESS-RELATED TRANSACTION & APPLICATION FOR BUILDING PERMIT SUBJECT TO THE REMITTANCE OF THE AFORESAID FEE TO THE CORRESPONDING BARANGAY", CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE SANGGUNIANG BAYAN, PURSUANT TO SECTION 447(a)(1) OF THE LOCAL GOVERNMENT CODE.
