A RESOLUTION AUTHORIZING THE HONORABLE GOVERNOR NIÑO SOTERO L. UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) WITH THE PHILIPPINE SPORTS COMMISSION (PSC), REPRESENTED BY ITS CHAIRMAN, MR. RICHARD E. BACHMANN, RELATIVE TO THE LAUNCHING AND IMPLEMENTION OF THE 2024 LARO'T SAYA SA DAVAO ORIENTAL.

WHEREAS, presented for consideration before the August Body is a letter from the Honorable Governor Niño Sotero L. Uy, Jr., dated May 20, 2024, requesting for the passage of a resolution for the aforementioned subject matter;

WHEREAS, the Philippine Sports Commission (PSC) implemented "Larot Saya sa Parke" since January 2013, which anchored on the principle of "Play and learn sports for free", in adherence to the provisions stipulated in Article XIV, Section 19 of

the 1987 Philippine Constitution which states: "the State shall promote physical education and encourage sports programs, league competitions, and amateur sports, including training for international competitions, to foster self-discipline, teamwork, and excellence for the development of a healthy and alert citizenry"; and Republic Act 6847, otherwise known as the "The Philippine Sports Commission Act";

WHEREAS, Chapter 3, Section 465(b)(1)(vi) of Republic Act No. 7160, provides that the Provincial Governor, as the Chief Executive of the Provincial Government, shall "represent the province in all its business transactions and sign in its behalf of all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance";

WHEREFORE, on motion of SP Member Andy A. Monday, duly and jointly seconded by SP Members Anna Cheryl N. Castro, Jossone Michael G. Dayanghirang, Daud V. Linsag, Stephen Paul L. Uy, and Harold A. Montes, it was
