RABAT OF MATI, DAVAO ORIENTAL, RE: “AMENDING EXECUTIVE ORDER NO. 43 SERIES OF 2024, RE: “REGULATING THE TRAFFIC FLOW AND IMPOSING TRUCK BAN IN THE ALTERNATE ROAD IN BARANGAY TAGABAKID, CITY OF MATI, BY UPDATING SEVERAL OF THE GUIDELINES”, CONSIDERING THAT THE SAME IS WITHIN THE PRESCRIBED POWERS OF THE CITY MAYOR PURSUANT TO ARTICLE I, SECTION 455(b)(2)(iii) OF REPUBLIC ACT 7160.

WHEREAS, it is deemed imperative to regulate the traffic flow in the alternate road in Barangay Tagabakid, City of Mati, this province, to ensure public safety, and mitigate traffic congestion among others, thereby, City Mayor Michelle N. Rabat issued the aforementioned executive order;
