WHEREAS, the Regional ROTC Annual Administrative and Tactical Inspection (RAATI) is a scheduled yearly activity administered by the 11th Regional Community Defence Group (11RCDG), Reserve Command Philippine Army (RCPA) to determine the existing condition of the activated ROTC units in terms of administration, personnel, training, facilities, training aids, equipment and support extended by the schools; evaluate the degree and quality of training attended by the ROTC cadets vis-à-vis performance of Army personnel assigned in the ROTC Unit in the region as a basis for awards and recognitions; and determine the extent of support provided by the school whether the ROTC funds are judicially utilized;


WHEREAS, the test and evaluation was conducted to all activated PA ROTC Units within Region XI started last May 14, 2024 and ended on May 21, 2024 under the supervision of the 11th Regional Community Defense Group, Reserve Command, Philippine Army in coordination with the 10th Infantry (Agila) Division, Philippine Army;
