A RESOLUTION CONFIRMING THE VALIDITY OF CITY ORDINANCE NO. 602, SERIES OF 2024, OF THE SANGGUNIANG PANLUNGSOD OF MATI, DAVAO ORIENTAL, ENTITLED: "AN ORDINANCE INSTITUTIONALIZING THE CITY SPORTS EVENTS/PROGRAMS DURING THE CITYHOOD AND SAMBUOKAN FESTIVALS CELEBRATION OF THE CITY OF MATI DUBBED AS RAJAH SPORTSFEST, APPROPRIATING FUNDS FOR THE IMPLEMENTATION THEREOF AND FOR OTHER PURPOSES", SUBJECT TO EXISTING LAWS, RULES, AND REGULATIONS RELATIVE THERETO.
