UY, JR., FOR AND IN BEHALF OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL, TO SIGN A DEED OF DONATION WITH THE DEPARTMENT OF HEALTH- DAVAO CENTER FOR HEALTH DEVELOPMENT, REPRESENTED BY ITS REGIONAL DIRECTOR, DR. ANNABELLE P. YUMANG, MCH, CESO III, OF ONE (1) UNIT COASTER VAN CONVERTED INTO A MOBILE LABORATORY CLINIC EQUIPPED WITH VARIOUS MEDICAL EQUIPMENT.






