**A RESOLUTION CONVENING THE HONORABLE MEMBERS OF THE 17th SANGGUNIANG PANLALAWIGAN OF DAVAO ORIENTAL SITTING EN BANC AS INVESTIGATING BODY TO EXERCISE ITS QUASI JUDICIAL POWERS AND FUNCTIONS IN RESOLVING SP ADMINISTRATIVE CASE NO. 17-02-2024 EFFECTIVE IMMEDIATELY.**

**WHEREAS**, the Sangguniang Panlalawigan is vested with the powers to investigate, hear and decide administrative disciplinary cases against erring local elective officials of municipalities in the province pursuant to Section 60 to 66 of RA 7160, otherwise known as the Local Government Code of 1991 in relation to Rule XIX, Article 124 to 130 of its Implementing Rules and Regulations (IRR);

**WHEREAS**, the Sangguniang Panlalawigan as a quasi-judicial body shall be the Investigating Authority and shall act on all administrative complaints, duly verified, filed against local elective officials of municipalities in the province;

**WHEREAS**, Section 65, of the Local Government Code of 1991 (RA 7160) provides that: *“the respondent shall be accorded full opportunity to appear and defend himself in person or by counsel, to confront and cross-examine the witnesses against him, and to require the attendance of witnesses and the production of documentary evidence in his favor through the compulsory process of subpoena or subpoena duces tecum”*;

**WHEREFORE**, after careful review of all circumstances in connection with instant case, and to exercise the quasi-judicial functions of the Sangguniang Panlalawigan, on motion of SP Member Harold A. Montes, duly and jointly seconded by SP Members Eleuterio C. Manaytay, Stephen Paul L. Uy, Daud V. Linsag, Andy A. Monday, and Shanine C. Lintogonan, it was




