A RESOLUTION DECLARING APPROPRIATION ORDINANCE NO. 02-17-2024 OF THE MUNICIPALITY OF SAN ISIDRO, DAVAO ORIENTAL, OPERATIVE IN ITS ENTIRETY, SUBJECT TO SOME CONDITIONS.

WHEREAS, Appropriation Ordinance No. 02-17-2024 of the Municipality of San Isidro, Davao Oriental, authorizing its CY 2024 General Fund Supplemental Budget No. 02, involving an appropriation of THREE MILLION SIX HUNDRED SIXTY-SEVEN THOUSAND PESOS (₱3,667,000.00), was submitted to this Sanggunian for review on May 29, 2024, pursuant to the provisions of Republic Act No. 7160;

WHEREAS, the subject Appropriation Ordinance shows substantial compliance with the same law and its Implementing Rules and Regulations;

WHEREFORE, on motion of SP Member Rotchie M. Ravelo, duly and jointly seconded by SP Members Daud V. Linsag, Eleuterio C. Manaytay, Shanine C. Lintogonan, Jossone Michael G. Dayanghirang, Michelle M. Centeno, Marietta D. Palmera, Stephen Paul L. Uy, and Harold A. Montes, it was

THE SANGGUNIANG PANLALAWIGAN IN SESSION DULY ASSEMBLED:

RESOLVED, to declare Appropriation Ordinance No. 02-17-2024 of the Municipality of San Isidro, Davao Oriental, **OPERATIVE IN ITS ENTIRETY** as of its stated effectivity date, subject to the posting requirements under Section 59 of RA No. 7160, and subject further to the following conditions:

- 1. The appropriations for the PPAs in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP) / Development Fund, pursuant to Sections 287 and 305(i) of RA 7160; DILG MC No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016.
- 2. The LGU is reminded of Section 56 in relation with Sections 326 and 327 of the Local Government Code which provides that within three (3) days after approval of the Ordinance authorizing annual or supplemental appropriations, the Secretary to the Sanggunian shall forward the said Ordinance to the appropriate reviewing authority.

RESOLVED FURTHER, to inform the Municipality of San Isidro, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

RESOLVED FINALLY, to send a copy of this Resolution to the Sangguniang Bayan of San Isidro, Davao Oriental, through the Municipal Mayor.
