**WHEREAS**, Appropriation Ordinance No. 02-20-05-2024 of the Municipality of Cateel, Davao Oriental, authorizing its **CY 2024 General Fund Supplemental Budget No. 02**, involving an appropriation of **EIGHT MILLION SEVEN HUNDRED FIVE THOUSAND FOUR HUNDRED PESOS (₱8,705,400.00)**, was submitted to this Sanggunian for review on May 31, 2024, pursuant to the provisions of Republic Act No. 7160;

The fund appropriation for PPAs funded in this budget shall be in accordance with the approved CY 2024 Annual Investment Program (AIP) and/or Supplemental Annual Investment Program (SAIP), pursuant to Sections 287 and 305(i) of RA 7160; DILG Memorandum Circular No. 2004-130, dated October 1, 2004; DILG-NEDA-DBM-DOF Joint Memorandum Circular No. 1, s. 2016, dated November 18, 2016.
2. Fund appropriation intended for payment of RATA to its officials shall be in accordance with DBM LBC No. 157, dated May 3, 2024.
3. The LGU is reminded that the Appropriation Ordinance shall carry the seal of the LGU, per LBR Form No. 1B of the Budget Operation Manual (2023 Edition) of the Department of Budget and Management.

**RESOLVED FURTHER**, to inform the Municipality of Cateel, Davao Oriental, that this review action does not authorize any item of appropriation that is specifically prohibited by or inconsistent with the provisions of law.

**RESOLVED FINALLY**, to send a copy of this Resolution to the Sangguniang Bayan of Cateel, Davao Oriental, through the Municipal Mayor.


