A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 01, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF CARAGA, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE CREATING THE POSITION OF PLUMBING AND TINNING INSPECTOR II WITH SALARY GRADE 10 UNDER THE WATERWORKS SECTION OF THE OFFICE OF THE MUNICIPAL MAYOR, PROVIDING FOR ITS QUALIFICATIONS, AND APPROPRIATING FUNDS FOR THE PURPOSE”, SUBJECT TO EXISTING CIVIL SERVICE LAWS, RULES AND REGULATIONS, AND APPLICABLE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991.

WHEREAS, submitted for review of this August Body is the abovementioned Municipal Ordinance which was referred to the Committee on Labor, Employment, Civil Service and Human Resource Development on July 31, 2024, for appropriate action;

WHEREAS, Section 76 of the Republic Act No. 7160, otherwise known as the Local Government Code of 1991, provides that: "Every local government unit shall design and implement its own organizational structure and staffing pattern taking into consideration its service requirements and financial capability, subject to the minimum standards and guidelines prescribed by the Civil Service Commission";


