A RESOLUTION CONFIRMING THE VALIDITY OF MUNICIPAL ORDINANCE NO. 02, SERIES OF 2024, OF THE SANGGUNIANG BAYAN OF CARAGA, DAVAO ORIENTAL, ENTITLED: “AN ORDINANCE RENAMING THE POSITION TITLE OF ADMINISTRATIVE AIDE II (UTILITY WORKER) UNDER THE OFFICE OF THE SECRETARY TO THE SANGGUNIANG TO LOCAL LEGISLATIVE STAFF EMPLOYEE I (UTILITY WORKER), THEREBY AMENDING MUNICIPAL ORDINANCE NO. 09 S. 2023”, SUBJECT TO EXISTING CIVIL SERVICE LAWS, RULES AND REGULATIONS, AND APPLICABLE PROVISIONS OF THE LOCAL GOVERNMENT CODE OF 1991.
