WHEREAS, Chapter III, Section 465(b)(1)(vi) of the Local Government Code of 1991, states that the Provincial Governor, as the Chief Executive of the Provincial Government, shall “represent the province in all its business transactions and sign in its

behalf all bonds, contracts, and obligations, and such other documents upon authority of the sangguniang panlalawigan or pursuant to law or ordinance”;

WHEREAS, presented for consideration before the August Body is an urgent request from the Honorable Governor Niño Sotero L. Uy, Jr., thru his letter, dated August 12, 2024, requesting for the passage of a resolution authorizing him, for and in behalf of the Provincial Government of Davao Oriental, to enroll in the Land Bank Institutional Internet Banking “weAccess”;

WHEREAS, requested for further consideration is the authorization/designation of the Provincial Treasurer, Maria Victoria G. Rodriguez and Provincial Accountant Maria Patricia Theresa H. Templa, as the Authorizers; Arnel R. Manio, Administrative Aide III, as the Maker for General Fund and Special Education Fund; and Aprille Jane M. 




