## RECONSTITUTING THE PROVINCIAL STATISTICS COMMITTEE (PSC)

**WHEREAS**, the Philippine Statistics Authority (PSA) Board, thru PSA Resolution No. 05, Series of 2015, established the Regional Statistics Committee (RSC) to provide direction and guidance to regional/local statistical development activities and serve as the policymaking body on statistical matters and serve as the venue for discussion and resolution of statistical issues at the local level;

**WHEREAS**, at the provincial level, the demand for data to support development planning, implementation and monitoring of programs, projects and activities has increased in view of the decentralization thrust of the government;

**WHEREAS**, sectoral actions to address the demand for data can have a better impact when coordinated and integrated;

**WHEREAS**, such coordinated and integrated action can be made possible through a mechanism that will bring sectors together for shared decision making and responsibility on matters related to statistical development policies and activities;

**NOW THEREFORE**, by the powers vested in me by law, **I, NIÑO SOTERO L. UY, JR.**, Provincial Governor, do hereby reconstitute the Provincial Statistics Committee (PSC):

### Section 1: Duties and Functions of the Committee

The PSC was organized for the purpose of implementing the following functions:

1. Oversee the implementation of policy decisions made by the PSA Board and the adoption of prescribed statistical standard methodologies and classification system in the province;
2. Coordinate and guide the implementation of statistical development activities;
3. Monitor and evaluate the generation of data by determining its outcomes and impacts;
4. Conduct regular meeting every quarter or as maybe necessary for planning, review and evaluation.

### Section 2. Composition

The PSC shall be composed of the:


### Section 3. Secretariat.
