



**EXECUTIVE ORDER NO. 16**

**RECONSTITUTION OF SECTORAL COMMITTEES UNDER THE  
PROVINCIAL DEVELOPMENT COUNCIL (PDC)**

**WHEREAS**, Local Government Code (LGC) mandates the creation of the Local Development Council which shall assist the Sanggunian in setting the direction of economic and social development and coordinate development efforts within its jurisdiction;

**WHEREAS**, the *Provincial Development Council (PDC)* has been reconstituted through Executive Order No. 15 Series 2023 as the highest policy-making body in the province, in coordinating and setting the direction of all economic and social development efforts, and further, serving as a forum where local efforts can be related and integrated with provincial development activities;

**WHEREAS**, to enable the PDC to carry out its duties and responsibilities, sectoral committees shall be created to comprehensively manage respective concerns on social, economic, environment, infrastructure, finance and development administration/institutional development and peace and order, public safety and security concerns;

**WHEREAS**, the sectoral committees shall review and endorse matters pertaining to their concern to the PDC;

**NOW, THEREFORE**, I, **NIÑO SOTERO L. UY, JR.**, Provincial Governor of Davao Oriental, by virtue of the power vested in me by existing laws, do hereby order the reorganization of the Sectoral Committees under the Provincial Development Council (PDC) as follows;

***Section 1- Composition***

## ***Section 2- Secretariat***

There shall be created secretariat by each committee to provide technical support and documentation, preparation of reports and such other assistance as may be required. The Head Secretariat of each committee shall come from the PPDO, while other member agencies should contribute relevant manpower & expertise of the same.

## ***Section 3- Meetings and Quorum***

The *Sectoral Committees* shall meet quarterly without prejudice to whenever necessary. The Chairperson, Co-Chairperson or Vice-Chairperson may invite other pertinent agencies to share inputs to the committee.

Sectoral Committees shall submit to the PDC through PPDO their accomplishment, activities and proposals every quarter or whenever appropriate.

The operational funds of the Sectoral Committees shall be provided by the LGU chargeable against the General Fund and other sources.

## ***Section 4- Repealing Clause***

All Executive Orders, rules and regulations or parts thereof, which are inconsistent with any provisions of this Executive Order, are hereby repealed, amended, or modified accordingly.

## ***Section 5- Effectivity***

This Executive Order shall take effect immediately.
