AN EXECUTIVE ORDER RECONSTITUTING THE ENHANCED COMPREHENSIVE LOCAL INTEGRATION PROGRAM (E-CLIP) COMMITTEE FOR THE PROVINCE OF DAVAO ORIENTAL

WHEREAS, the Department of the Interior and Local Government (DILG) and Department of National Defense (DND) Joint Memorandum Circular No. 2018 dated July 5, 2018 mandates to create at the Provincial level the E-CLIP Committee;

WHEREAS, social integration is a vital part of the peace process and post-agreement security reform, and an essential part of confidence and peace building measure;

WHEREAS, the Province of Davao Oriental supports the reintegration program of the national government for former rebels (FRs);

WHEREAS, there is a need to amend the CLIP Committee E-CLIP Committee for this province to determine the eligibility of former rebels (FRs) to avail of the national and local assistance;

NOW THEREFORE, I, NIÑO SOTERO L. UY, JR., Governor of the Province of Davao Oriental, by virtue of the power vested in me by the law, do hereby order:

Section 1. Composition. There is hereby amended Enhanced Comprehensive Local Integration Program (E-CLIP) Committee to be composed of the following:

Section 2. Duties and Functions. The Enhanced Comprehensive Local Integration Program (E-CLIP) Committee shall:

1. Ensure the convergent effort in the delivery of the identified service of the program;

2. Ensure proper documentation and referral of the needs of the FRs to appropriate agencies and other partner institutions including getting the profile of the FRs;
3. Facilitate the profiling of the FRs, through the PSWDO;
4. Assist the FR in completing the E-CLIP Enrolment Form. The FR should either sign or thumb mark Form after completing it, attested by the DILG Provincial Director and approved by the Provincial Governor or his designated officer preferably the Provincial Administrator or PSWDO;
5. Assist the FR in the preparation of his/her Former Rebel Reintegration Plan (FRRP) and Business Plan, with the PSWDO as the lead agency to assist the FR. It shall have the option to come-up with its template (form) of FRRP and Business Plan, as long as the minimum datasets reflected in the Sample Forms in Annexes E and F are considered;
6. Resolve issues and concerns affecting the implementation of the E-CLIP;
7. Provide updates to the PPOC during its meetings regarding the progress of the E-CLIP;
8. Coordinate and monitor the E-CLIP implementation in the Province; and
9. The co-chairperson shall give an update re: E-CLIP implementation during the Provincial Peace and Order Council meetings.

The Technical Working Group shall:

1. Provide Valuable inputs and technical assistance in all the areas that are relevant to the implementation of Enhanced Comprehensive Local Integration Program (E-CLIP); and
2. Formulate the Enhanced Comprehensive Local Integration Program (E-CLIP) Committee Implementation Plan.
3. Schedule a TWG-meeting to validate the completeness and consistency of documents of FRs before uploading to the ECLIP-IS for processing of financial claims.

Section 4. **Budgetary Requirements.** All incidental expenses needed for the facilitation of the program will be charged against the Provincial Peace and Order Council (PPOC) funds of Davao Oriental.

Likewise, an honorarium shall be granted to the present CSO Representative of the E-CLIP Committee during the meeting.

Section 5. **Effectivity.** This Executive Order shall take effect immediately.
