## EXECUTIVE ORDER NO. 21 Series of 2023

# RECONSTITUTION OF THE BIDS AND AWARDS COMMITTEE OF THE PROVINCIAL GOVERNMENT OF DAVAO ORIENTAL

WHEREAS. Republic Act No. 9184, known as the "Government Procurement Reform Act", and its 2016 Revised Implementing Rules and Regulations, provides that each Procuring Entity shall establish a single Bids and Awards Committee (BAC) for its procurement which shall have at least five (5) but not more than seven (7) members;

WHEREAS, Section 11 of R.A. 9184 provides that unless sooner removed for a cause, the members of the BAC shall have a fixed term of one (1) year reckoned from the date of appointment, renewable at the discretion of the Head of Procuring Entity (HOPE);

NOW THEREFORE, I NIÑO SOTERO L. UY, JR., Provincial Governor of Davao Oriental, by virtue of the power vested in me, do hereby reconstitute the Bids and Awards Committee (BAC) of the Provincial Government of Davao Oriental:

Section 1. Composition of BAC. The BAC is hereby reconstituted and shall be composed of the following, to wit:

Section 2. Powers, Functions, and Duties. The BAC shall perform the functions pursuant to Section 12.1 of the Revised IRR of R.A. 9184 and other issuances of the Government Procurement Policy Board (GPPB). Moreover, BAC functions shall give utmost priority over all other duties and responsibilities until the requirements from the procurement at hand are completed, and shall perform jury duty whenever so required.

Section 3. BAC Secretariat. The BAC Secretariat shall perform the functions and responsibilities stipulated in section 14.1 of the Revised IRR of RA 9184 and issuance of the GPBB.

Section 4. Technical Working Group (TWG). The TWG shall assist the BAC in the conduct of activities as enumerated under Section 12.1 (m) of the Revised IRR of RA 9184, and such others as may be authorized issuances of the GPPB, the Head of the Procuring Entity (HOPE) or by the BAC itself.

Section 5. Observers. To enhance the transparency of the process, the BAC shall, during the eligibility checking, shortlisting, pre-bid conference, preliminary examination of bids, bid evaluation, and post qualification, invite, in addition to the representative of the COA, at least two (2) observers, who shall not have the right to vote, to sit in its proceedings.

Section 6. Honoraria. Qualified members of the BAC shall be entitled to a monthly honorarium not exceeding twenty five percent (25%) of their respective monthly salary, subject to availability of funds and existing rules and regulations.

Section 7. Repealing Clause. All Executive Orders, rules and regulations or parts thereof, which are in consistent with any provision of this Executive Order, are hereby repealed, amended, and/or modified accordingly.

Section 8. Effectivity. This Executive Order shall take effect immediately and shall be valid until revoked or amended.
