**AN EXECUTIVE ORDER INSTITUTIONALIZING THE MORAL RECOVERY
PROGRAM COUNCIL OF ADVISORS (MRPCA) IN THE PROVINCE OF DAVAO
ORIENTAL**

WHEREAS, Proclamation No. 62 dated September 30, 1992, declared a national campaign for moral recovery in response to the need to strengthen the moral resources of the Filipino people rooted in Filipino culture, values and ideals that are pro-God, pro-people, pro-country, and pro-nature. The proclamation has declared the Moral Recovery Program as official government policy and enjoined the active participation of all sectors in Filipino Society;

WHEREAS, Executive Order No. 319 which was issued on 3 April 1996 institutionalized the Moral Recovery Program in all government departments, offices, agencies, and government owned and controlled corporations;

WHEREAS, Provincial Ordinance No. 15-10-02-2017 "*An Ordinance Institutionalizing the Moral Recovery Program in the Province of Davao Oriental Appropriating Funds therefore and for other purposes*", strengthens the moral values of its constituents through the quadrangular vision of MAKA-DIYOS, MAKA-TAO, MAKA-BAYAN, MAKAKALIKASAN which are deeply rooted in our Filipino culture; promote the shared Filipino core values as fundamental basis of the Moral Recovery Program;

NOW THEREFORE, I NIÑO SOTERO L. UY, JR., by virtue of the powers vested upon me by law as Governor of the Province of Davao Oriental, do hereby order the institutionalization of the Moral Recovery Program Council of Advisors (MRPCA) in the Province of Davao Oriental.

Section II - Duties and Functions of the MRPCA.

The MRPCA shall have the following duties and functions:

- A. Serves as the advisory and policy-making body of the program;
- B. Provides direction in the effective implementation of the program in all the different levels of government, departments, office, agencies/instrumentalities operating within the province;
- C. Establish a monitoring system as guide for the secretariat for the assessment/evaluation of the progress and effectiveness of the program;
- D. Formulates the MRP and good citizenship values program of the province;
- E. Enjoins all the government departments, offices, agencies, instrumentalities, and GOCCs to establish Integrity Circles or similar mechanisms to lay the necessary foundations of the moral recovery crusade for Filipino core value infusions into the organization's culture, systems and processes; and
- F. Performs other duties and functions as maybe prescribed by law, ordinance and other issuances.

Section III - Creation of the Secretariat and its Composition. The Secretariat shall be composed of the following officials and personnel:

A. Secretariat Head: PASTOR RUBEN L. COLMO, JR. - Provincial MRP Officer

B. Members : EVERINDO L. ESVER - PGO, Chief of Staff
VIRGILIA N. BERNALDEZ - PGADH-PHRMDO
ALIM ALJON DECATAN

Section IV - Duties and Responsibilities of the Secretariat. The Secretariat shall exercise the following functions:

- A. The Secretariat shall be in-charge of the scheduling and facilitating the trainings, reports and other work for the council. It will likewise be the point of contact of all the other line agencies the council is tied up with.
- B. Provides technical support, document proceedings and prepares report.
- C. Monitors and evaluates the conduct of trainings, status of program implementation and performance of those involved in the program.
- D. Renders such other assistance as the council may require in discharging its functions.

Section V - Repealing Clause. All prior issuances on the organization and functions of the Moral Recovery Program inconsistent herewith shall be deemed superseded by this Order.

Section VI - Effectivity. This Executive Order shall take effect immediately.
