**EXECUTIVE ORDER NO. 30**  
Series of 2023

**AN EXECUTIVE ORDER INSTITUTIONALIZING THE MORAL RECOVERY PROGRAM IN THE PROVINCE OF DAVAO ORIENTAL, DESIGNATING PASTOR RUBEN L. COLMO JR. AS THE PROVINCIAL MRP OFFICER (PMRPO)**

**WHEREAS**, Proclamation No. 62 dated September 30, 1992, declared a national campaign for moral recovery in response to the need to strengthen the moral resources of the Filipino people rooted in Filipino culture, values and ideals that are pro-God, pro-people, pro-country, and pro-nature. The proclamation has declared the Moral Recovery Program as official government policy and enjoined the active participation of all sectors in Filipino Society;

**WHEREAS**, Executive Order No. 319 which was issued on 3 April 1996 institutionalized the Moral Recovery Program in all government departments, offices, agencies, and government owned and controlled corporations;

**WHEREAS**, Provincial Ordinance No. 15-10-02-2017 "*An Ordinance Institutionalizing the Moral Recovery Program in the Province of Davao Oriental Appropriating Funds therefore and for other purposes*", strengthens the moral values of its constituents through the quadrangular vision of **MAKA-DIYOS, MAKA-TAO, MAKA-BAYAN, MAKAKALIKASAN** which are deeply rooted in our Filipino culture; promote the shared Filipino core values as fundamental basis of the Moral Recovery Program;

**WHEREAS**, Section 6 of Provincial Ordinance No. 15-10-02-2017, mandates the designation of the Provincial Moral Recovery Program Officer (PMRPO) by the Governor;

**NOW THEREFORE**, I NIÑO SOTERO L. UY, JR., by virtue of the powers vested upon me by law as Governor of the Province of Davao Oriental, do hereby order the designation of Pastor RUBEN L. COLMO JR. as the Provincial MRP Officer in the Province of Davao Oriental.

**Section 1. Duties and Functions of the Provincial MRP Officer.**

The Provincial MRP Officer shall have the following duties and functions:

- a. The PMRPO shall implement the MRP and good citizenship values province-wide with the Provincial Human Resource & Management Development Office (PHRMDO) as support staff together with the Moral Recovery Officers duly designated by the respective head/chief of national agencies and by the local executives and Barangay chairmen in case of the local government units;

- b. The PMRPO shall conduct training of values formation in the Province;
- c. The PMRPO shall be guided by the policy established by the Provincial MRP Council of Advisors; and
- d. The PMRPO will administer the secretariat which will all together stand as the technical working group and support team for the MRP Council of Advisors.

## **Section 2. Creation of the Secretariat and its Composition.**

There will be a secretariat that will altogether, stand as the technical working group. The secretariat will be administered by the PMRPO. Initially, the secretariat will be composed of three (3) technical officers coming from different sectors of the society where one must come from the Muslim Sector in order to integrate impartial views, practices and tradition in line with the implementation of Provincial Ordinance No. 15-10-02-2017.

## **Section 3. Secretariat's Functions.**

The Secretariat shall exercise the following functions:

- a. Provide technical support, document proceedings and prepares report;
- b. Coordinate with all the government agencies/departments concerned regarding the implementation of the Moral Recovery Program; and
- c. Monitor and evaluates the conduct of trainings, status of program implementation and performance of those involved in the program.

## **Section 4. Appropriation.**

The Provincial Government shall set aside reasonable allocation as initial funding to ensure the implementation of the Moral Recovery Program in the Province of Davao Oriental.

## **Section 5. Support for the Program.**

Pursuant to the Provincial Moral Recovery or values development program approved by the MRPCA, all department offices, agencies or instrumentalities operating within the province, all LGU's shall extend full support to the program through the establishment of integrity circles.

## **Section 6. Separability.**

If any part of this Order is held unconstitutional; or invalid, other provisions not affected thereby shall remain in full force and effect.

**Section 7. Repeal.**

All other orders, guidelines,, rules, regulations and issuances or parts thereof, which are inconsistent with the provisions of this Order are hereby repealed or modified accordingly.

**Section 8. Effectivity.**

This Executive Order takes effect immediately upon its approval.
