**RECONSTITUTION OF THE INSTITUTIONAL STRENGTHENING COMMITTEE  
(ISC) OF THE PROVINCIAL GOVERNMENT  
OF DAVAO ORIENTAL**

**WHEREAS**, the **Institutional Strengthening Committee (ISC)** was created by virtue of Executive Orders No. 4, series of 2019 and No. 9, series of 2021 to continuously review and rationalize the present organizational structure and operations of the provincial government offices departments in order to meet the challenges and exigencies of public service, attune itself to local and global operatives and deliver;

**WHEREAS**, there is a need to keep-up with the devolution transition plans of the national government and in our efforts to champion good governance;

**WHEREAS**, the Provincial Governor's Office regularly receives requests from various provincial government department / offices for staffing modifications such as abolition and conversion of funded vacant positions and the creation of new positions, majority of which are not anymore relevant to the changing times and kinds of governance;

**NOW, THEREFORE, I, NIÑO SOTERO L. UY, JR.**, Governor of the Province of Davao Oriental, by virtue of the powers vested in me by law and in conformity with the foregoing, do hereby reconstitute the Institutional Strengthening Committee of the Provincial Government of Davao Oriental:

*Section 4. Honoraria* - All members and secretariat including resource persons shall be entitled to receive honoraria, subject to the usual accounting and auditing rules and regulations, as follows:

Chairperson and Members	- P5,000.00 /meeting
Secretariat	- P3,000.00 / meeting
Resource Person	- P2,000.00 / per invitation or meeting

*Section 5. Meetings* - The committee shall prescribe their own meeting schedules but should not be less than one (1) meeting in a month. The committee is also given three (3) months to submit reports and /or recommendations to the governor.

*Section 6. Funding Appropriation* - There shall be available funds appropriated for the committee for expenditures necessary for the conduct of their duties and responsibilities subject to usual general accounting procedures.

*Section 7. Separability Clause* - Any portion or provision of this Executive Order that may be declared unconstitutional shall not have the effect of nullifying other portions or provisions hereof as long as such remaining portions or provisions can still subsist and be given effect in their entirety.

*Section 8. Repealing Clause* - All executive issuance, orders or provisions thereof which are inconsistent with any provision of this Executive Order are hereby repealed or modified accordingly.

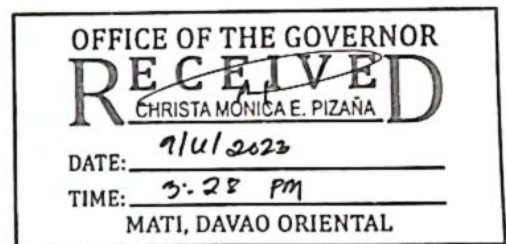
