EXECUTIVE ORDER NO. 32

**AN ORDER CREATING THE SEAL OF GOOD LOCAL GOVERNANCE FOR BARANGAY (SGLGB) PROVINCIAL PERFORMANCE ASSESSMENT TEAM OF THE PROVINCE OF DAVAO ORIENTAL**

**WHEREAS**, Section 3 (h) and (m) and Section 16 of the Republic Act No. 7160, otherwise known as the Local Government Code (LGC) of 1991, provide that there shall be a continuing mechanism to enhance local autonomy not only by legislative enabling acts but also by administrative and organizational reforms, that the national government shall ensure that decentralization contributes to the continuing improvement of the performance of local government units (LGUs) and the quality of community life, that each LGU shall exercise its powers essential to the promotion of the general welfare and provisions of basic services and facilities;

**WHEREAS**, the Department of the Interior and Local Government (DILG) issued Memorandum Circular 2023-103 dated July 28, 2023 stated that cognizant of the important role of the barangay in the overall development and transformation of the community and of the nation, the Department undertakes to implement the Seal of Good Local Governance for Barangay (SGLGB) to encourage and challenge barangays to scale up its performance of good governance that accord primacy to the principle of accountability, transparency, performance and effectiveness;

**WHEREAS**, the SGLGB is an award and incentive program for performing barangay governments in the areas of Peace and Order, Financial Administration, Disaster Preparedness, Social Protection, Business-Friendliness and Competitiveness, and Environmental Management and shall institutionalize a system of recognition and incentive awards for barangay governments and to provide mechanics for possible access to Performance Challenge Fund (PCF) and other incentive mechanisms available;

**NOW, THEREFORE, I, NIÑO SOTERO L. UY, JR.**, Governor, Province of Davao Oriental, by virtue of the powers vested in me by the law, do hereby order:

**SECTION 1. CREATION AND COMPOSITION.** The Provincial Performance Assessment Team (PPAT) is hereby created and shall be composed of the following:

**SECTION 2. DUTIES AND FUNCTIONS.** The Committee shall perform the following duties and functions:

1. Validate the data of barangays based on the assessment of CC/M SGLGB Assessor to ensure its correctness;
2. Approve and sign the Provincial Consolidated Performance Assessment Form (PCPAF, SGLGB Form 6); and
3. Ensure the completion of the provincial validation within the scheduled timeframe.

**SECTION 3. DUTIES AND FUNCTIONS OF THE SECRETARIAT OF THE PPAT.** The Secretariat shall perform the following duties and functions:

1. Present to the PPAT, during the validation meeting, all the submitted CC/M CPAF (SGLGB Form 4) together with the accomplished DCF (SGLGB Form 2) and MOVs;
2. Facilitate the accomplishment and signing of the PCPAF (SGLGB Form 6); and
3. Submit the signed PCPAF to the PPAT.
4. Perform other functions as needed.

**SECTION 4. BUDGETARY REQUIREMENTS.** All incidental expenses needed to facilitate the program will be charged against the Provincial Governor's Office Funds. Likewise, an honorarium may be granted to the members of PPAT and Secretariat subject to the availability of funds and to the usual accounting, auditing rules and regulations.

**SECTION 4. EFFECTIVITY.** This Executive Order shall take effect immediately.
